THE COMPARATIVE STUDY OF ACADEMIC ORGANIZATIONS IN THE PHYSICAL EDUCATION, SPORTS, AND LEISURE IN TAIWAN, UNITED STATES, EUROPE, AND AUSTRALIA

establishment time of the other countries' academic organizations were longer than Taiwanese organizations, the situation of the number of membership, publication and conference were better than Taiwanese. Meanwhile, the establishment time of Taiwanese academic organizations in PE, sports, and leisure were less than other countries' about 20 years, so it was not very well in organizational planning, especially in website.

In the meantime, it was also because of the late of academic research in PE, sports, and leisure in Taiwan, the academic organizations established later as well. It was also not to say that the relevant information of Taiwanese academic organizations was lack. But at present, the Taiwanese academic organizations were at the stage of rising day by day, and many scholars in PE, sports, and leisure fields had completed the education and returned to Taiwan successively, and then joined to the human resource incubation system one after another. Based on that, the academic organizations of PE, sports, and leisure in Taiwan would catch up the international trends and found out the position in the world.
