### **EASM Membership fees and benefits**

The EASM Board reviewed the membership fees and benefits over the last months from several perspectives. Based on some tax concerns, the results from the membership survey and several intensive discussions with long-term EASM members, the Board proposes three options for the membership fee for the financial year 2019/20 and onwards.

These three options are summarised below and will be also presented at the AGM, as stipulated by EASM Charter 7.5 byelaw. The EASM Board proposes to vote only for one option.

7.5 The General Assembly shall be empowered to: f) ... determine membership fees.

Byelaw § 6.4.2: Membership fees shall be determined from time to time by the General Assembly, on the recommendation of the Board. If a recommendation is not approved, or no recommendation is presented, then existing fees shall continue to apply.
